



From the Desk of Dean Melissa Essary

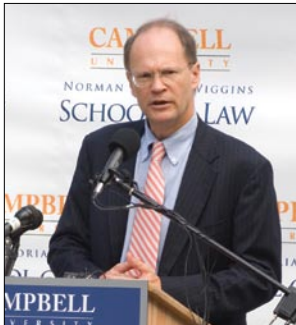

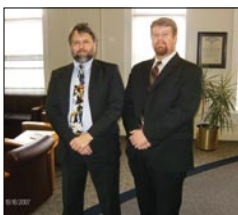
